1. Bidding Procedure

- This E-tender will be under 2 bid system (Technical and Financial).
- The Financial bid will be in BOQ format (to be submitted online). The successful bidder will be selected on the basis of minimum rates (inclusive of all taxes) quoted by the bidder.
- The contract period of the successful bidder will commence only after successful procurement of all the necessary items/equipments/ Furniture etc by Municipal Corporation, Rudrapur for the ABC centre.(a separate E-Tender has alreadybeen floated for it).
- The estimated cost per of ABC-ARV surgery is Rs 1092/ Stray dog whichcan be increased by 5% on annual basis.
- The contract period will be 1 year from the date of issuance of work order to the successful bidder. This period can be increased further for a period of 1 year by Municipal Commissioner, Rudrapur for 1 year on satisfactory work and written request of the successful bidder
- 1.1 To be qualified for the work, the bidder/consortium of (bidder) entitled as per ABC (dog) rule 2023 should meet the following requirements –

- (a) Any bidder or consortium of bidder working in the field of animal welfare/related activities including ABC-ARV surgery of stray dogs in India and having the office of lead member of the consortium in India, are eligible to submitthe bids.
- (b). The bidder should be well aware and conversant with the methodologies of carrying out ABC-ARV Program and street dogs, as per the SOP published by in the AWBI in the light of ABC (Dog) Rule 2023.
- (c) The bidder should have successfully carried out a minimum of 30,000 ABC-ARV surgeries of stray dogs within last 5 financial years (01 April 2018 to 31March 2023)
- Along with the documentary proof in support of above requirements, bidder shall upload the scan copy of the following documents on the e-tendering website www.uktenders.gov.in accordingly:-
- (i). Copy of registration with AWBI or SAWB which should be valid at the time of bid submission, and in case of consortium the registration of lead member shall be mandatory. A self attested copy to be attached with the technical bid document.
- (ii) Copy of the registration certificate-trust deed (registration under FCRA, or Society Registration Act-Trust act or any other act) of the applicant organization or group of bidders. A self attested copy to be attached with the technical bid document.
- (iii)Written consent that in this ABC-ARV program same catching technique, transportation Protocols, De-wormers, Vaccines, Drugs. Suture Material, Aesthetic Protocol, Surrical Protocol, handling &maintenance of dogs shall be followed as per the "standard operative procedure for sterilization of stray dogs under the animal birth control program" published by AWBI. A self attested copy to be attached with the technical bid document.
- (iv) Written consent from the bidder that they shall deploy minimum 03 qualified veterinary doctors having collective experience minimum of 5000 MC-ARV Surgeries of stray dogs, minimum 05 Para vets & at least 08 Dog Catchers Including at least 20% resident of Uttarakhand. However, once the financial bid is finalized, the qualifying firm will have to provide the CVs of the subject 3 doctors before signing of the contract.
 - (v) An affidavit that the bidder has not been blacklisted by any Centre or State authorities/Local Body all over India.
- (vi) Minimum- 1 Staff shall be deployed for humane education who will report directly to Municipal Commissioner, Municipal Corporation, Rudrapur or the officer nominated by Municipal Commissioner on weekly basic as well.

- (vii) Copy of Turnover certificate (with UDIN NO.) showing a minimum amount of Rs. 60 Lakh for the last financial year i.e 2022-23. In case, the Turnover certificate for a period of F'Y 2022-23 is not available, the Turnover certificate for financial year 2021-2022 can be considered.
- (viii) Bidder shall submit written consent for bid validity of 4 months.
- (ix) The bid proposal should be submitted online on www.uktenders.gov.in and Bids.
- (x) Demand Draft of 5,900.00 in favour of Municipal Commissioner, Municipal Corporation Rudrapur.

- 1.6 The harzard / untoward incidents of any kind which the eligible bidders come across while carrying out the survey of the stray / street dogs (after this work is awarded to the eligible bidder) would be at the ask and cost of that bidder.
- 1.7 Municipal Corporation, Rudrapur reserves the right to cancel any or all bids at any stage of the process without assigning any reasons thereof to the concerned bidders)

2- Background.

- 2.1 Animal birth control anti-rabies programme order is to be implemented in compliance to order from Hon'ble Supreme Court of India order dated 18/11/2015 on SNP no. 691 / 2009 AWBI vs People for elimination of stray trouble and others or order dated 4/03/2014 from Hon'ble Nainital High Court on WPIL no. 41/2013 Gauri Maulildiivs Govt. Of Uttarakhand programme is to be implemented as per the animal birth control Dog rules 2023 for management of stray dog population in the area under Municipal Corporation, Rudraur's jurisdiction.
- 2.2 Prime target should be oriented to at least 90% of total stray dog population, ensuring surgical sterilization and Anti Rabies Vaccination within a period of two years. In this Mass Scale ABC-ARV Program, only those Material, Aesthetic Protocol, Surgical Protocol, Handling and Maintenance of Dogs shall he followed which confirms the 'Standard Operative Procedure for Sterilization of Stray Dogs' under the Animal Birth Control Program publishedby AWBI.
- 2.3The ABC Campuses shall be provided to bidder Including Operation Theatre + Kennels + Well Constructed Rooms + other basic infrastructure like Operation Tables, Drip Stands, Autoclave, Basic Furniture, Refrigerator, Washing machine, Inverter, Dog Vans etc.

3- Scope of Work.

- 3.1The bidder shall deploy minimum 03 Qualified Veterinary Doctors with the collective experience of at least 5,000 ABC-ARV Surgeries, at least 05 Para vets, minimum 08 dog Catchers & drivers for dog vans.
- 3.2 Dog vans will be provided by the Municipal Corporation, Rudrapur. These dog vans will be operated by the bidder. All expenses pertaining to operation & maintenance including insurance, tyres & tubes, battery and drivers of these dog vans will be borne by the bidder. Cost towards satisfactory repair of the damages to the vehicles during operation, if any, shall have to be borne by the bidder, failing which, such cost shall be liable for deduction from eligible payments of the bidder. The dog vans shall have to be returned back to the respective Municipal Corporation in best working condition after completion of the contract.

It shall be the responsibility of the bidder to carry out -

- a) catching the street/stray dogs
- b) transport up to the ABC campuses

- c) pre & post-operative feeding/care of stray dogs
- d) mass scale ABC Surgery & Anti Rabies Vaccination as per ABC SOP published by AWBI.
- e) re-transport the dogs from ABC campuses back to their original street/ location. The successful bidder shall submit a certificate stating the number of stray dogs transported back to their original street/ location after operating them, on monthly basis.
- 3.4 Municipal Corporation, Rudrapur authorities will provide and water facility in the ABC campus. However electricity and water charges shall be borne by the bidder.
- 3.5 The bidder shall attempt to achieve zero mortality, however the mortality rate should not exceed more than 0.5%, otherwise the contract shall be terminated and the EMD of the successful bidder will be forfeited. Mortality rate to be checked afterevery 1,000 ABC-ARV surgeries.
- 3.6 The bidder shall provide surgical equipment kit Medicines. Suture material computer Stationery, & Feeding Material to ABC campuses at its own cost forwhich payment shall be borne by the successful bidder.
- 3.7 The successful bidder shall be regularly preserving the organ; after the surgery in different jars. Payment for the ABC-ARV shall be made based on Organ Count Basis verified by the Veterinary Officer of Municipal Corporation, Rudrapur, Uttarakhand Regular re-verification of organ count shall be done chief Veterinary Officer Udhamsingh Nagar or Joint Director, Uttarakhand Animal Welfare Board or State Government or any Senior authority from Municipal Corporation, Rudrapur Uttarakhand. Such payments are to be made on monthly basis.
- 3.8 The bidder shall provide a FDR/Demand Draft of Rs 3,00,000.00 (Three Lakh Only) as Earnest Money Deposit (EMD) in favour of Municipal Commissioner, Rudrapur that shall be released after 03 month of successful completion of the contract period.
- 3.9 In case mobilization advance is sought by the successful bidder, minimum mobilization advance of 10% of accepted contract shall be paid against security in form of unconditional Bank Guarantee/FDR/Draft in favor of Municipal Corporation, Rudrapur.
- 3.10 Mobilization Advance shall be deducted from eligible monthly payments to the Firm. All statutory deductions, as applicable, shall be made from the eligible payment to the Bidder.
- 3.11 On verbal or written directions (as the case may be) from Municipal Commissioner, Municipal Corporation, Rudrapur, the day to day activities beingrun by successful bidder may be inspected any time.
- 3.12 In case, the date of opening of the tender is public holiday, the tender will be opened on the next working day at the same time.

- 3.13 Municipal Commissioner, Rudrapur reserves the right to reject any one or all the bids at any time. He will not be bound to inform the reason for such action.
- 3.14 In case of any dispute, the decision given by the Municipal Commissioner, Municipal Corporation, Rudrapur will be binding. If the successful bidder does not agrees with that decision. The matter will be settled through the arbitrator. In this context, District Magistrate, Udhamsingh Nagar (or any arbitrator nominated by him) will be the arbitrator. The arbitrator's fee, if any, will be borne half-to-half by both the parties. The arbitrator's decision shall be bindingto both the parties.
